Barangay Bunaliuan Mayor General Fund Supplemental Budget No. 2010-001 for CY 2010, involving an appropriation of P120,842.50, approved by the Sangguniang Barangay on November 7, 2010 and enacted under Appropriation Ordinance No. 2010-002

Barangay #4 (Poblacion) General Fund Supplemental Budget No. 2010-001 for CY 2010, involving an appropriation of P117,876.30, approved by Sangguniang Barangay on November 6, 2010 and enacted under Appropriation Ordinance No. 2010-002

Barangay #7 (Poblacion) General Fund Supplemental Budget No. 2010-002 for CY 2010, involving an appropriation of P81,274.02, approved by Sangguniang Barangay on October 10, 2010 and enacted under Appropriation Ordinance No. 2010-003

Barangay Olo Barroc General Fund Supplemental Budget No. 2010-001 for CY 2010, involving an appropriation of P68,146.70, approved by Sangguniang Barangay on September 18, 2010 and enacted under Appropriation Ordinance No. 2010-002
