RESOLUTION CONFORMING AND APPROVING THE CY 2010 SUPPLEMENTAL BUDGETS EMBODYING APPROPRIATION ORDINANCES OF THE FOLLOWING BARANGAYS: SIPITAN, PARARA NORTE, DAPDAP AND CANABUAN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on November 30, 2010 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2010 Supplemental Budgets Embodying Appropriation Ordinances of the following barangays:

Barangay Sipitan General Fund Supplemental Budget No. 2010-001 for CY 2010, involving an appropriation of P83,272.45 approved by Sangguniang Barangay on November 20, 2010, and enacted under Appropriation Ordinance No. 2010-002.

Barangay Parara Norte General Fund Supplemental Budget No. 2010-001 for CY 2010, involving an appropriation of P65,760.10, approved by Sangguniang Barangay on November 27, 2010 and enacted under Appropriation Ordinance No. 2010-002.

Barangay Dapdap General Fund Supplemental Budget No. 2010-001 for CY 2010, involving an appropriation of P106,989.95, approved by Sangguniang Barangay on October 3, 2010 and enacted under Appropriation Ordinance No. 2010-002.

Barangay Canabuan General Fund Supplemental Budget No. 2010-001 for CY 2010, involving an appropriation of P71,329.95, approved by Sangguniang Barangay on October 2, 2010 and enacted under Appropriation Ordinance No. 2010-02.

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Supplemental Budgets which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Supplemental Budgets embodying Appropriation Ordinances for CY 2010 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of HON. JOSE DONEL TRASPORTO, Vice Chairman Committee on Appropriation, Budget, Finance and Legal Matters and duly seconded by Hon. Dennis Valencia, Hon. Agaton O. Tumabotabo, Hon. Elmer Torrato, Hon. Ricky Nulada and Hon. Nyssa Nichola Callosa,

RESOLVED, to conform and approve the CY 2010 Supplemental Budgets Embodying Appropriation Ordinances Of The Following Barangays: Sipitan, Parara Norte, Dapdap and Canabuan, this municipality,
