RESOLUTION CONFORMING AND APPROVING THE CY 2010 SUPPLEMENTAL BUDGETS EMBODYING APPROPRIATION ORDINANCES OF THE FOLLOWING BARANGAYS: BAYUCO, 2 (POBLACION), CANSILAYAN, BAGUINGIN AND BITAS, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on December 22, 2010 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2010 Supplemental Budgets Embodying Appropriation Ordinances of the following barangays:

***Barangay Bayuco** General Fund Supplemental Budget No. 2010-002 for CY 2010, involving an appropriation of P58,973.45, approved by Sangguniang Barangay on December 12, 2010 and enacted under Appropriation Ordinance No. 2010-003 .*

***Barangay 2 (Poblacion)** General Fund Supplemental Budget No. 2010-002 for CY 2010, involving an appropriation of P74,557.05, approved by Sangguniang Barangay on December 11, 2010 and enacted under Appropriation Ordinance No. 2010-003 .*

***Barangay Cansilayan** General Fund Supplemental Budget No. 2010-002 for CY 2010, involving an appropriation of P47,779.45, approved by Sangguniang Barangay on December 11, 2010 and enacted under Appropriation Ordinance No. 2010-003 .*

***Barangay Baguingin** General Fund Supplemental Budget No. 2010-002 for CY 2010, involving an appropriation of P40,725,.66, approved by Sangguniang Barangay on December 11, 2010 and enacted under Appropriation Ordinance No. 2010-003 .*

***Barangay Bitas** General Fund Supplemental Budget No. 2010-002 of for CY 2010, involving an appropriation of P22,000.00, approved by Sangguniang Barangay on December 19, 2010 and enacted under Appropriation Ordinance No. 2010-003 .*

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Supplemental Budgets which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Supplemental Budgets embodying Appropriation Ordinances for CY 2010 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;
