**Resolution No. 2011-001**

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR JAMES EXCELSIOR M. TORRES TO ENTER INTO A MEMORANDUM OF UNDERTAKING (MOU) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) TO EXTEND ASSISTANCE TO THE PESO TO ENSURE THE SUCCESSFUL CONDUCT OF THE SRS PROJECT IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, a letter dated January 7, 2011 of Hon. Mayor James Excelsior M. Torres requesting a Resolution Authorizing The Municipal Mayor To Enter Into A Memorandum Of Undertaking (MOU) With The Department Of Labor To Extend Assistance To The PESO To Ensure The Successful Conduct Of The SRS Project;

WHEREAS, unemployment and underemployment continue to be the perennial problems among Filipinos and these problems are attributable to many factors, among which are (1) inability of the economy to generate new jobs; (2) labor market imperfections; and (3) lack of information about labor market supply and demand;

WHEREAS, the national government is committed to the organization, development and maximum utilization of the country's manpower resources;

WHEREAS, the Department of Labor and Employment is a government agency concerned with employment promotion, regulation, stimulation and labor market statistics;

WHEREAS, the DOLE has embarked to undertake the establishment of a Skills Registry System (SRS), a continuing nationwide manpower skills registration with the existing Phil-JobNet as the repository of the Registry;

WHEREAS, the SRS is envisioned to enhance the databank of manpower supply with their corresponding skills and qualifications for ready access of employment service clients;

WHEREAS, the SRS aims to strengthen the current system of Register of labor demand from employers that shall be available to both jobseekers and employers;

WHEREAS, the Municipality of Tigbauan, Iloilo, in coordination with the DOLE, had established a Public Employment Service Office (PESO) in order to realize the objectives of the local government to deliver quality employment services to its constituents;

WHEREAS, the Tigbauan PESO shall be needing relevant labor market information, specifically on the nature of its available workforce, in order to effectively facilitate the employment of those currently unemployed and assist the business establishments in sourcing qualified manpower to tilt their existing vacancies;

WHEREAS, for and in consideration of the above premises, the DOLE and the Municipality of Tigbauan hereby agree as they have agreed to cooperate and undertake the SRS Project subject to the following delineated allocation of responsibilities stated in the MOU which is attached as Annex "A";
