**Resolution No. 2011-002**

RESOLUTION INTERPOSING NO OBJECTION/OPPOSITION (IN LINE WITH THE DENR'S PRIORITY PROGRAM FOR CY 2010) ON THE ISSUANCE OF PRESIDENTIAL PROCLAMATION AND SPECIAL PATENT FOR SCHOOL SITES, PARTICULARLY BINALIUAN MAYOR ELEMENTARY SCHOOL, BINALIUAN MAYOR NATIONAL HIGH SCHOOL, CORDOVA NATIONAL HIGH SCHOOL, CORDOVA ELEMENTARY SCHOOL, BAROSONG NATIONAL HIGH SCHOOL, AND BUYU-AN ELEMENTARY SCHOOL, ALL IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Municipal Mayor, Hon. James Excelsior M. Torres, this municipality, through his letter dated November 19, 2010, addressed to (*former Liga President*) Hon. Orvillo Tangente, *SB Chair, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation* requested for the passing of SB Resolution relative to the issuance of Presidential Proclamation and Special Patent for school sites, particularly Binaliuan Mayor Elementary School, Binaliuan Mayor National High School, Cordova National High School, Cordova Elementary School, Barosong National High School, and Buyu-an Elementary School, in line with the DENR'S priority program for CY 2010;

WHEREAS, in a letter dated October 28, 2010, Mr. Valentin P. Talabero, PENRO Officer, DENR/PENRO, Iloilo City, informed the Hon. Mayor James Excelsior M. Torres (*Attn.: The Sangguniang Bayan, Tigbauan, Iloilo*), that one of the requirements for the issuance of Special Patent to the above cited schools is a Resolution Signifying Non Objection/Opposition in the implementation of said program;

WHEREAS, based on the letters by the OIC, PENR Officer, Valentin P. Talabero to Raymundo A. Lapating, Ph.D. CESO V, Schools Division Superintendent, DepEd,

Division of Iloilo, La Paz, Iloilo City, the following schools had been identified by the DENR as potential areas for the issuance of Special Patent for school sites:

- a.) Binaliuan Mayor Elementary School and Binaliuan Mayor High School, both located at Binaliuan Mayor, Tigbauan, Iloilo with an area of 7,751sq.m. and 2,000 sq. m., respectively,
- b.) Cordova High School, Cordova Elementary School both located at Cordova Norte, Tigbauan, Iloilo with an area of 2,000 sq. m. and 9,901 sq. m., respectively,
- c.) Barosong High School situated at Barosong , Tigbauan, Iloilo with an area of 2,000 sq. m.
- d.) Buyu-an Elementary School situated at Buyu-an, Tigbauan, Iloilo with an area of 7,339 sq. m.

WHEREAS, considering the importance of this program to the benefit of the schools cited above, the Sangguniang Bayan strongly supports such project of the DENR. Said schools are therefore urged to comply and/or submit vital documents to the DENR in order to have this project/program materialized leading to the issuance of Presidential Proclamation and Special Patent;
