RESOLUTION REPRIMANDING HONORABLE ELMER T. TORRATO ON HIS FOUR (4) UNAUTHORIZED CONSECUTIVE ABSENCES.

WHEREAS, as per record of the S.B. Secretary, Hon. Elmer T. Torrato was absent for 4 consecutive sessions scheduled – December 29, 2010, January 7, 2011, January 14, 2011 and January 21, 2011 which were all unauthorized;

WHEREAS, aside from this four consecutive absences of Hon. Elmer Torrato, he already had an habitual absences from the previous months during his term of Office without due notice to the SB Office;

WHEREAS, as approved in consonance with the provisions of the Rules and Regulations Implementing the Local Government Code of 1991 governing the Sanggunian's, Internal Rules of Procedure, Rule III - Duties & Responsibilities of Individual Members (Section 2) states that every member shall attend all the sessions of the Sanggunian unless he/she is prevented from doing so by reason of sickness or the S.B. Member is on vacation leave, official travel or other official business, other unavoidable circumstances provided that, as a general rule, notice thereto shall be sent to the Sanggunian thru the Presiding Officer or the S.B. Secretary in writing before the session;

WHEREAS, in the Rules & Regulations Implementing the Local Government Code of 1991–Rule XIX – Article 124 (par. a and b) states that an elective local official may be censured, reprimanded, suspended or removed from office after due notice. He/She may be removed from office on the grounds enumerated in paragraph (a) of this Article by order of the proper court or the disciplinary authority whichever first acquires jurisdiction to the exclusion of the other;

NOW, THEREFORE, on motion of Hon. Agaton Tumabotabo, Vice Chairman, Committee on Good Government, Public Ethics, Accountability & Civil Service and duly seconded by Hon. Dennis Valencia, Hon. Jose Donel Trasporto, Hon. Loreta Lungay-Arias, Hon. Marlon Teruñez and Hon. Ricky Nulada,

RESOLVED, to reprimand Honorable Elmer T. Torrato on his four (4) unauthorized consecutive absences,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Mayor James Excelsior M. Torres, Hon. Elmer Torrato and all concerned for their information, guidance and/or appropriate action.
