RESOLUTION APPROVING THE JOINT COMMITTEE REPORT OF THE COMMITTEE ON RULES, ORDINANCES AND RESOLUTIONS AND COMMITTEE ON BARANGAY AFFAIRS AND ADOPTING THE RECOMMENDATIONS DECLARING VALID THE BARANGAY ORDINANCE NO. 2011-001 OF BRGY. ALUPIDIAN, TIGBAUAN, ILOILO ENTITLED "AN ORDINANCE PROHIBITING ANY PERSON TO DISRUPT OR CAUSE TROUBLE DURING BARANGAY ACTIVITIES AND PROVIDING PENALTIES IN VIOLATION THEREOF"

"Presented for consideration of the Body is the Committee Report No. 2011-006 of the Joint committee on Rules, Ordinances and Resolution and Committee on Barangay Affairs with the Chairmen, Hon. Jose Donel Trasporto, and Hon. Ricky Nulada, respectively, relative to Brgy. Alupidian Ordinance No. 2011-001, "AN ORDINANCE PROHIBITING ANY PERSON TO DISRUPT OR CAUSE TROUBLE DURING BARANGAY ACTIVITIES AND PROVIDING PENALTIES IN VIOLATION THEREOF";

WHEREAS, SEC. 16. General Welfare – Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities

improve public morals, enhance economic prosperity and social justice , promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, SEC. 391. Power, Duties and Functions. – The Sangguniang Barangay, as the legislative body of the barangay, shall: Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinance and to promote the general welfare of the inhabitants therein;

RESOLVED, to approve the Joint Committee Report of the Committee on Rules, Ordinances and Resolutions and Committee on Barangay Affairs and Adopting the Recommendations Declaring Valid the Barangay Ordinance No. 2011-001 of Brgy. Alupidian, Tigbauan, Iloilo Entitled: “An Ordinance Prohibiting Any Person to Disrupt or Cause Trouble During Barangay Activities and Providing Penalties in violation Thereof”
