RESOLUTION REQUESTING THE MUNICIPAL MAYOR FOR THE IMMEDIATE IMPLEMENTATION OF MUNICIPAL ORDINANCE NO. 2010-007 – *“AN ORDINANCE IMPOSING LEASEHOLD RIGHTS DEPOSIT AND MONTHLY RENTAL FEES ON PHASE 1 AND 2 OF THE NEWLY- CONSTRUCTED TIGBAUAN PUBLIC MARKET”* AND FOR THE IMMEDIATE CONDUCT OF BIDDING.

WHEREAS, Municipal Ordinance No. 2010-007 was approved by the Sangguniang Bayan last September 1, 2010;

WHEREAS, because of the various problems that they have encountered in the public market, our constituents specially the affected stallholders are urging the municipal officials to strictly implement said ordinance as soon as possible specially the immediate conduct of bidding;

WHEREAS, recently, the Sanggunian is again bombarded by various complaints in the public market such as the robbery incidents that took place in the public market especially during night time;

WHEREAS, with the immediate implementation of said ordinance, the Allera Street being used as temporary space for the relocation of the old stallholders can be re-opened again for the smooth flow of traffic in the public market;
