RESOLUTION CONFORMING AND APPROVING THE CY 2011 ANNUAL BUDGETS AND 20% DEVELOPMENT PLANS OF THE FOLLOWING BARANGAYS: BAGUINGIN, LANAG, 6 (POBLACION), BUYU-AN, CORDOVA SUR, 8 (POBLACION), DAPDAP, AND NAPNAPAN NORTE, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on February 3, 2011, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Barangay Annual Budgets and 20% Barangay Development Plans of the following barangays:

WHEREAS, the appropriations for the Annual Budgets and 20% Development Fund of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets and 20% Development Fund shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;
