RESOLUTION CONFORMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGET EMBODYING APPROPRIATION ORDINANCE OF BARANGAY PARARA NORTE, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on February 4, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budget Embodying Appropriation Ordinance of barangay:

Barangay Parara Norte General Fund Supplemental Budget No. 2011-001 for CY 2011, involving an appropriation of P324,687.26, approved by Sangguniang Barangay on January 8, 2011 and enacted under Appropriation Ordinance No. 2011-002.

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Supplemental Budget which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the appropriation for the Supplemental Budget of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budget shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;
