**Resolution No. 2011-020**

RESOLUTION CONFORMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGET EMBODYING APPROPRIATION ORDINANCE OF BARANGAY 8 (POBLACION), THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on February 17, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budget Embodying Appropriation Ordinance of barangay:

***Barangay 8 (Poblacion) General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P187,962.80, approved by Sangguniang Barangay on January 30, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Supplemental Budget which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the utilization of the Supplemental Budget shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of HON. JOSE DONEL TRASPORTO, Vice Chairman Committee on Appropriation, Budget, Finance and Legal Matters and duly seconded by Hon. Dennis Valencia, Hon. Alfonso Babiera, Hon. Agaton Tumabotabo, Hon. Marlon Teruñez, Hon. Ricky Nulada and Hon. Nyssa Nichola Callosa,
