**Resolution No. 2011-027**

RESOLUTION CONFORMING AND APPROVING THE CY 2011 ANNUAL BUDGETS AND 20% DEVELOPMENT PLANS OF THE FOLLOWING BARANGAYS: SIPITAN, DORONG-AN, ISIAN, BITAS. BUENAVISTA, GUISIAN, BAROSONG AND ALUPIDIAN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on March 12 and 17, 2011, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Barangay Annual Budgets and 20% Barangay Development Plans of the following barangays:

6. ***Brgy. Guisian CY 2011 General Annual Budget Involving An Appropriation of P654,572.00 and 20% Development Fund in the amount of P129,214.40*** Approved By Sangguniang Barangay On January 29, 2011 And Enacted Under Appropriation Ordinance No. 2011-01;
7. ***Brgy. Barosong CY 2011 General Annual Budget Involving An Appropriation of P999,153.00 and 20% Development Fund in the amount of P187,830.00*** Approved By Sangguniang Barangay On January 2, 2011 And Enacted Under Appropriation Ordinance No. 2011-01;
8. ***Brgy. Alupidian CY 2011 General Annual Budget Involving An Appropriation of P668,950.00 and 20% Development Fund in the amount of P131,990.00*** Approved By Sangguniang Barangay On January 15, 2011 And Enacted Under Appropriation Ordinance No. 2011-01;

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budgets and 20% Development Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Appropriation Ordinances embodying the Annual Budgets and 20% Development Plans for CY 2011 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriations for the Annual Budgets and 20% Development Fund of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets and 20% Development Fund shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;
