RESOLUTION CONFORMING AND APPROVING THE 2011 DEVELOPMENT PLAN AND 2011 ANNUAL INVESTMENT PLAN OF THE MUNICIPALITY OF TIGBAUAN

WHEREAS, the Municipal Development Council held a meeting last October 12, 2010 at the Municipal Conference Room, Tigbauan Municipal Hall;

WHEREAS, Resolution No. 2010-001 of the Municipal Development Council was submitted to the Sangguniang Bayan of Tigbauan, Iloilo, "Resolution Recommending Approval of the Prioritized Socio-Economic Development Projects from the CY 2011 20% Internal Revenue Allotment (IRA), Annual Investment Program for 2011 and Adoption of Executive Legislative Agenda (ELA) of the Municipality of Tigbauan, Province of Iloilo," copy of which is hereto attached as Annex "A", forming part of this Resolution;

WHEREAS, the total amount of prioritized programs and projects to be funded from the 2011 20% Internal Revenue Allotment (IRA) is THIRTEEN MILLION TWO HUNDRED FORTY THOUSAND SIX HUNDRED ONE PESOS and 60/100 (P13,240,601) to wit;

- a. The appropriation for 20% development fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;
- b. An appropriation of P1,020,000.00 under the Executive Services shall be for Community Direct Action Program (CDAP) under the direction of the Local Chief Executive while the amount of P600,000.00 under the Legislative Services shall be for Community Direct Action Program under the Legislative Services for the development projects of the fifty two (52) barangays under

- the direction of the Sangguniang Bayan Members and the Vice Mayor wherein which they have their respective areas of jurisdiction.
- c. Disbursement of the 20% development fund shall be made strictly pursuant to Joint Memorandum Circular No. 1 series of 2005 by DILG and DBM and Memorandum Circular No. 210-138 of the DILG Dated December 2, 2010.

WHEREAS, the total amount for programs, projects and activities embodied in CY 2011 Annual Investment Programs is ONE HUNDRED THIRTY NINE MILLION EIGHT THOUSAND EIGHT PESOS (P139,008,008.00);

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government units and the local chief executive;

NOW, THEREFORE, on motion of Hon. Suzette Tenefrancia-Alquisada, Chairperson, S.B. Committee on Appropriation, Budget, Finance and Legal Matters and duly seconded by Hon. Dennis Valencia, Hon. Elmer Torrato, Hon. Loreta Lungay-Arias, Hon. Marlon Teruñez, Hon. Ricky Nulada and Hon. Nyssa Nichola Callosa, Be It

RESOLVED, to conform and approve the 2011 Development Plan and 2011 Annual Investment Plan of the Municipality of Tigbauan, without prejudice to compliance of Joint Memorandum Circular No. 1 series of 2005 by DILG and DBM and Memorandum Circular No. 210-138 of the DILG Dated December 2, 2010, laws, rules and regulations, governing implementation of plans, programs and activities,
