RESOLUTION CONFORMING AND APPROVING THE CY 2011 ANNUAL BUDGET AND 20% DEVELOPMENT PLAN OF BARANGAY TAN PAEL, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on March 24, 2011, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Barangay Annual Budget and 20% Barangay Development Plan of the following barangay:

- 1. Brgy. Tan Pael CY 2011 General Annual Budget Involving An Appropriation Of P984,825.00 and 20% Development Fund in the amount of P192,060.00 Approved By Sangguniang Barangay On January 2, 2011 And Enacted Under Appropriation Ordinance No. 2011-01;**

WHEREAS, the appropriation for the Annual Budget and 20% Development Fund of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;
