CAYETANO, SENATOR OF THE REPUBLIC OF THE PHILIPPINES FOR FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE MILLION TWO HUNDRED THOUSAND PESOS (P1,200,000.00) FOR THE CONSTRUCTION OF BARANGAY HEALTH CENTER AT BARANGAY BAGUMBAYAN, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, it is one of the primary duties of the Local Government Unit to make health services accessible to the people;

WHEREAS, the Municipality of Tigbauan serves a total population of 61,130 as of the latest census;

WHEREAS, it is an accepted fact that here in Tigbauan you have prominent relatives surnamed “Cayetano” residing at Brgy. 9 (Poblacion), Tigbauan, who are actively supporting you, your brother – Sen. Allan Peter Cayetano, and the candidacy of your father – the late venerable Sen. Rene Cayetano,
