**Resolution No. 2011-036**

RESOLUTION CONFORMING AND APPROVING THE CY 2011 ANNUAL BUDGET AND 20% DEVELOPMENT PLAN OF BARANGAY SUPA, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on April 8, 2011, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Barangay Annual Budget and 20% Barangay Development Plan of the following barangay:

- 1. Brgy. Supa CY 2011 General Annual Budget Involving An Appropriation Of P702,009.00 and 20% Development Fund in the amount of P138,201.80**  
Approved By Sangguniang Barangay On February 27, 2011 And Enacted Under Appropriation Ordinance No. 2011-01;

WHEREAS, the appropriations for the Annual Budget and 20% Development Fund of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budget and 20% Development Fund shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;
