RESOLUTION AUTHORIZING PAYMENT IN THE AMOUNT OF THIRTY FIVE THOUSAND SIX HUNDRED NINETY SEVEN AND 80/100 (P35,697.80) PESOS FOR THE MONETIZATION OF MRS. NORA ROSE TUPAN TO BE TAKEN FROM THE P36,078.00 AVAILABLE SAVINGS (*FROM JANUARY 1 – MARCH 31, 2011*) OF THE VACANT POSITION OF AGRICULTURAL TECHNICIAN, SG 10-1, UNDER THE OFFICE OF THE MUNICIPAL AGRICULTURE.

WHEREAS, Mrs. Nora Rose Tupan, Administrative Aide I, requested for the monetization of her leave credits (*equivalent to 110 days*) to augment her unexpected medical expenses due to her recent operation;

WHEREAS, on April 26, 2011 the Hon. Mayor James Excelsior M. Torres issued Executive Order No. 015, S. 2011, authorizing the augmentation of the needed funds, and likewise formally requested this August Body on April 27, 2011 for the passing of a "*Resolution Authorizing the Transfer of Funds from PS Savings of the Municipal Agriculture Office to Treasurer's Office for the Payment of Monetization of Mrs. Nora Rose Tupan*";

WHEREAS, Sec. 22 and 23 of the Omnibus Rules on Leave, Rule XVI of the Omnibus Rules Implementing Book V of E.O. 292 provides for the privilege of monetization of vacation leave credits to employees and officials in the career service;

WHEREAS, there is an available Salary Savings from January 1 – March 31, 2011 in the amount of P36,078.00 from the vacant position of Agricultural Technician, SG 10-1, under the Office of the Municipal Agriculture as certified by Mrs. Pacita T. Ledesma, Municipal Budget Officer, this municipality;

WHEREAS, the payment of 110 days Leave Credit Monetization of Mrs. Nora Rose Tupan amounted to Thirty Five Thousand Six Hundred Ninety Seven and 80/100 (P35,697.80) Pesos;
