RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY CORAZON JULIANO-SOLIMAN, SECRETARY, IN THE IMPLEMENTATION OF NATIONAL HOUSEHOLD TARGETING SYSTEM FOR POVERTY REDUCTION (NHTS-PR)

WHEREAS, the First Party has a mandate to provide assistance to local government units, non government agencies, people's organizations, and other members of civil society in effectively implementing programs, projects and services that will alleviate poverty and empower disadvantaged individual, families and communities for an improved quality of life;

WHEREAS, the Second Party has a mandate to identify the basic needs of the needy disadvantaged, and the impoverished, develop and implement appropriate programs, projects and services related to social welfare to alleviate poverty and improve their living conditions;

WHEREAS, the First Party maintains a database on Filipinos through its National Household Targeting System for Poverty Reduction (NHTS_PR);

WHEREAS, the Second Party shall be allowed access to the data maintained under NHTS-PR;

WHEREAS, the feedback from the Second Party of the services and/or subsidies delivered and/or provided to the identified poor households is essential in strengthening and improving the NHTS-PR;

WHEREAS, for and in consideration of the above premises, the PARTIES hereby agree as follows:

THE FIRST PARTY:

1. Provide the SECOND PARTY with a User Name and Password that will be used to access data from the NHTS-PR, PROVIDED, that only the SECOND PARTY will use the said User Name and Password;
2. Provide the SECOND PARTY with the required data of NHTS-PR List of Household Living Below the Poverty Threshold for the Municipality of Tigbauan, Iloilo;
3. Provide the SECOND PARTY with technical assistance if and when so desired and/or requested.

The SECOND PARTY

1. Provide the FIRST PARTY with a complete list of data requirements and timeframe as to when the said data will be available;
2. In lieu of a "User's Fee" for all data requested, provide integration of NHTS-PR in all its social marketing activities highlighting emphasizing the use of targeting system in identifying beneficiaries of social protection programs and/or projects;
3. Accomplish the feedback report on data utilization as provided by the FIRST PARTY; and
4. Ensure the confidentiality and use requested data for purposes agreed upon only. Any breach thereof may be subject to legal action.

NOW, THEREFORE, on motion of Hon. Loreta Lungay-Arias and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton O. Tumabotabo, and Hon. Elmer Torrato,

RESOLVED, to authorize The Local Chief Executive to enter into a Memorandum Of Agreement (MOA) With The Department Of Social Welfare And Development (DSWD) Represented By Corazon Juliano-Soliman, Secretary, In The Implementation Of National Household Targeting System For Poverty Reduction (NHTS-PR),

RESOLVED FURTHER, to furnish copies of this resolution to Hon., James Excelsior M. Torres, Municipal Mayor, to DIR. Vincent Andrew T. Leyson, Project Manager, National Household Targeting System for Poverty Reduction (NHTS-PR) and to all concerned for their information and/or appropriate action.
