WHEREAS, the Municipal Budget Officer on June 1, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budget Embodying Appropriation Ordinance of barangay:

Barangay Napnapan Norte General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P120,918.47, approved by Sangguniang Barangay on April 2, 2011 and enacted under Appropriation Ordinance No. 2011-02.
