RESOLUTION CONFORMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGET EMBODYING APPROPRIATION ORDINANCE OF BARANGAY CORDOVA SUR, THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on July 1, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budget Embodying Appropriation Ordinance of barangay:

Barangay Cordova Sur General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P170,443.62, approved by Sangguniang Barangay on June 26, 2011 and enacted under Appropriation Ordinance No. 2011-02.

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;
