**RESOLUTION INTERPOSING NO OBJECTION TO THE CONTINUATION/COMPLETION OF THE MUNICIPAL ROAD CONCRETING PROJECT AT BARANGAY TAN PAEL, TIGBAUAN, ILOILO.**

WHEREAS, on July 01, 2011, representatives from the Department of Public Works and Highways attended the Regular Session of this Sanggunian to shed light on the queries as regards the stoppage of work in the road concreting project situated at Barangay Tan Pael, Tigbauan, Iloilo;

WHEREAS, according to the said representative of DPWH, there was work stoppage due to alleged Road Right of Way dispute;

WHEREAS, record shows that the said area, where the project is presently implemented is accordingly classified as Municipal Road;

WHEREAS, the representative of DPWH also expressed willingness to continue the project provided that there will be a clearance from the barangay and LGU to resume and proceed;

WHEREAS, the Barangay Officials of Barangay Tan Pael were also present during the S.B. session and they manifested that they are willing to cooperate, assist and render protection to DPWH workers in order for the project to be completed; they are one in saying that the said project will be beneficial to the constituents because the said road improvement will boost the economic and tourism potentials of the areas;

WHEREAS, upon representation to the August Body no body expressed any objection to the act of interposing no objection for the continuance of the project for the same is believed to be the general welfare of our people;
