RESOLUTION AMENDING RULE XVII – ENFORCEMENT OF ORDERS, DECORUM AND DISCIPLINARY ACTION, SECTION 5 OF RESOLUTION NO. 2010-038, OTHERWISE KNOWN AS THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIAN BAYAN OF TIGBAUAN, ILOILO

WHEREAS, it has been agreed by the August Body to amend Section 5 of Resolution No. 2010-038, otherwise known as the Internal Rules of Procedure of the Sangguniang Bayan of Tigbauan, Iloilo, to wit:

Section 5. *During regular sessions of the Sanggunian, Members of the August Body shall wear proper uniform/attire, to read:*

- *For 1st and 3rd S.B. Regular Sessions of the Month*
 - *Blue short jack for male, SB Members*
 - *Blue over coat for female, SB Members*
- *For 2nd and 4th S.B. Regular Sessions of the Month*
 - *White short jack for male, SB Members*
 - *White blouse for female, SB Members*
- *Provided, that if the Sanggunian shall have an out-to-the-barangay session, the Members of this August Body shall be free to choose any decent attire suited for a session and;*
- *Provided, further that if there are 5 weeks in a month, the Members of the Sanggunian shall also be allowed to wear short or long sleeves barong Tagalog for male SB Members and any semi formal attire for female SB Members; this is in addition to the usual prescribed uniforms with the official pin and I.D.*

NOW, THEREFORE, on motion of HON. JOSE DONEL TRASPORTO, Chairman, Committee on Rules, Ordinances and Resolutions and duly seconded by Hon. Dennis Valencia, Hon. Alfonso Babiera, Hon. Agaton Tumabotabo, Hon. Loreta Lungay-Arias, Hon. Ricky Nulada and Hon. Nyssa Nichola Callosa,

RESOLVED, to amend Rule XVII – Enforcement Of Orders, Decorum And Disciplinary Action, Section 5, Of Resolution No. 2010-038, Otherwise Known As *The Internal Rules Of Procedure Of The Sangguniang Bayan Of Tigbauan, Iloilo*,
