**RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-07-11-257 OF MARLENE T. NAVA ET-AL WITH TCT NO. T-9462, LOT NO. 927-A-9 WITH A TOTAL AREA OF 8,892 SQUARE METERS MORE OR LESS, CONTAINING SIX (6) LOTS LOCATED AT BRGY. NAMOCON, TIGBAUAN, ILOILO**

WHEREAS, the Subdivision Application of Marlene T. Nava Et-Al with Subdivision Approval No. SA-07-11-257 with TCT No. T-9462, Lot No. 927-A-9 with an area of 8,892 square meters containing six (6) lots located at Brgy. Namocon, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on July 14, 2011 for authorization and approval;

- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.
