RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM GOVERNOR ARTHUR D. DEFENSOR, SR., PROVINCE OF ILOILO IN THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (P400,000.00) FOR THE CODIFICATION PROJECT OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, as part of our effort to attain local efficiency consistent with our vision to become responsive to the needs and aspirations of our people, the Municipality of Tigbauan with the assistance of the DILG, DTI and the DENR is now on the process of implementing the Codification of Local Ordinances, particularly the **“Code of General Ordinances”, “Investment and Incentives Code” and the “Environment Code”**;

WHEREAS, relative to this Codification Project, we had conducted a two-day seminar on **“Local Legislation Enhancement Training With Focus On Codification”** last May 12 -13, 2011 at the Amigo Terrace Hotel after the signing of the MOA with the aforementioned government agencies last May 4, 2011 at the Iloilo Grand Hotel;

WHEREAS, one of the important topics/outputs that we had come-up during this seminar was the schedule and timetable of activities on the Codification Process which is expected to be accomplished in the first quarter of 2013;

WHEREAS, at present the municipality is on the stage of conducting its mock hearings for the said codes but this was not completed yet due to lack of funds;

WHEREAS, the implementation of other codification programs/activities specially the reproduction of voluminous copies of said codes for purposes of public hearings and compliance with the posting and publication requirement entails a lot of finances;

WHEREAS, due to financial constraints, the municipality has appropriated a meager budget for said project and no other sources of funds was seen for the completion thereof;

WHEREAS, the financial assistance and support of the good Governor will be of great help to finish this codification project;

NOW, THEREFORE, on motion of HON. DENNIS T. VALENCIA, and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon. Jose Donel Trasporto, Hon. Elmer Torrato, Hon. Loreta Lungay-Arias, Hon. Marlon Teruñez and Hon. Nyssa Nichola Callosa,

RESOLVED, to request Financial Assistance From Governor Arthur D. Defensor, Sr., Province Of Iloilo In The Amount Of Four Hundred Thousand Pesos (P400,000.00) For The Codification Project Of The Municipality Of Tigbauan, Province Of Iloilo,
