RESOLUTION CONFORMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGET EMBODYING APPROPRIATION ORDINANCE OF BARANGAY SUPA, THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on August 4, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budget Embodying Appropriation Ordinance of barangay:

Barangay Supa General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P23,000.00, approved by Sangguniang Barangay on July 31, 2011 and enacted under Appropriation Ordinance No. 2011-02.

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of HON. JOSE DONEL TRASPORTO, Vice Chairman, Committee on Appropriation, Budget, Finance, and Legal Matters and duly seconded by Hon. Agaton Tumabotabo, Hon. Elmer Torrato, and Hon. Ricky Nulada,
