WHEREAS, the Housing and Urban Development Coordinating Council (HUDCC), is a Government Agency created by virtue of Executive Order No. 90 (s. 1986) issued by President Corazon C. Aquino and its attached Housing Agencies, the Housing and Land Use Regulatory Board (HLURB), the Home Development Mutual Fund (HDMF), the National Home Mortgage Finance Corporation (NHMFC), the Social Housing Finance Corporation (SHFC), the National Housing Authority (NHA) and the Home Guaranty Corporation (HGC), will be spearheaded the Pabahay Program;
