RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-08-11-259 OF FLODELIZA T. TAJANLANGIT ET-AL WITH TCT NO. F-48347, LOT NO. 3035 WITH A TOTAL AREA OF 6,539 SQUARE METERS MORE OR LESS, CONTAINING FOURTEEN (14) LOTS LOCATED AT BRGY. PARARA NORTE, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application of Flordeliza T. Tajanlangit with Subdivision Approval No. SA-08-11-259 with TCT No. F-48347, Lot No. 3035 with an area of 6,539 square meters containing fourteen (14) lots located at Brgy. - e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.
