**RESOLUTION CONFORMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGET
EMBODYING APPROPRIATION ORDINANCE OF BARANGAY ATABAYAN, THIS

WHEREAS, the Municipal Budget Officer on August 10, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budget Embodying Appropriation Ordinance of barangay:

***Barangay Atabayan General Fund Supplemental Budget No. 2011-01 for CY 2011,
involving an appropriation of P227,233.08, approved by Sangguniang Barangay on
