RESOLUTION CONFORMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGET EMBODYING APPROPRIATION ORDINANCE OF BARANGAY ATABAYAN, THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on August 10, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budget Embodying Appropriation Ordinance of barangay:

Barangay Atabayan General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P227,233.08, approved by Sangguniang Barangay on August 7, 2011 and enacted under Appropriation Ordinance No. 2011-02.

and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;
