RESOLUTION CONFORMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGET OF BARANGAYS NAMOCON AND CORDOVA NORTE, THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on September 8, 2911 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budget Embodying Appropriation Ordinance Of Barangays:

Barangay Namocon General Fund Supplemental Budget No. 2011-01 for CY 2011 involving an appropriation of P132,425.09, approved by Sangguniang Barangay on August 1, 2011 and enacted under Appropriation Ordinance No. 2011-03;

Barangay Cordova Norte General Fund supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P108,924.50, approved by Sangguniang Barangay on August 21, 2011 and enacted under Appropriation Ordinance No. 2011-02.

WHEREAS, the Review of the foregoing Supplemental Budgets embodying Appropriation Ordinance for CY 2011 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;
