RESOLUTION CONFORMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGETS OF THE BARANGAYS JAMOG, BUYU-AN, LANAG, BAGUINGIN, ISAUAN, BITAS, BARANGAY # 8 (POBLACION), DORONG-AN, THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on September 22, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budgets Embodying Appropriation Ordinance of barangays:

Barangay Jamog General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P120,485.98, approved by Sangguniang Barangay on September 17, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Buyu-an General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P102,717.35, approved by Sangguniang Barangay on September 18, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Lanag General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P146,949.00, approved by Sangguniang Barangay on August 22, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Baguingin General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P83,760.30, approved by Sangguniang Barangay on September 2, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Isauan General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P30,919.05, approved by Sangguniang Barangay on September 4, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Bitas General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P235,267.75, approved by Sangguniang Barangay on September 18, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay 8 (Poblacion) General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P134,377.50, approved by Sangguniang Barangay on September 4, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Dorong-an General Fund Supplemental Budget No. 2011-02 for CY 2011, involving an appropriation of P437,751.85, approved by Sangguniang Barangay on September 4, 2011 and enacted under Appropriation Ordinance No. 2011-03.

WHEREAS, the Review of the foregoing Supplemental Budgets embodying Appropriation Ordinance for CY 2011 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;
