**RESOLUTION CONFORMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGETS OF THE BARANGAYS: 3 (POBLACION), BAGACAY, PARARA SUR, LUBOG, 2 (POBLACION), 6 (POBLACION), PARARA NORTE, AND OLO BARROC, THIS MUNICIPALITY**

WHEREAS, the Municipal Budget Officer on October 14, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budgets Embodying Appropriation Ordinance of barangays:

***Barangay 3 (Poblacion) General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P95,224.00, approved by Sangguniang Barangay on September 18, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

***Barangay Bagacay General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P147,924.86, approved by Sangguniang Barangay on September 18, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

***Barangay Parara Sur General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P432,804.70, approved by Sangguniang Barangay on October 2, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

***Barangay Lubog General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P97,983.81, approved by Sangguniang Barangay on October 1, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

***Barangay 2 (Poblacion) General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P163,705.75, approved by Sangguniang***

***Barangay on September 25, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

***Barangay 6 (Poblacion) General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P78,080.85, approved by Sangguniang Barangay on September 20, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

***Barangay Parara Norte General Fund Supplemental Budget No. 2011-02 for CY 2011, involving an appropriation of P201,374.40, approved by Sangguniang Barangay on September 24, 2011 and enacted under Appropriation Ordinance No. 2011-03.***

***Barangay Olo Barroc General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P163,526.52, approved by Sangguniang Barangay on July 31, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

WHEREAS, the Review of the foregoing Supplemental Budgets embodying Appropriation Ordinance for CY 2011 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;
