RESOLUTION AUTHORIZING HON. JAMES EXCELSIOR M. TORRES, MUNICIPAL MAYOR, TO REPRESENT THE MUNICIPALITY OF TIGBAUAN AS ONE OF THE SIGNATORIES TO THE MEMORANDUM OF AGREEMENT BY AND BETWEEN DA RFU-VI AND THE MUNICIPALITY OF TIGBAUAN FOR PROJECT BANANA (CARDABA) PRODUCTION AND PROCESSING.

WHEREAS, Mayor James Excelsior M. Torres sent a letter to the Sangguniang Bayan, this municipality dated November 10, 2011, requesting for the passing of a *“Resolution Authorizing Him To Represent The Municipality Of Tigbauan As One Of The Signatories To The Memorandum Of Agreement (MOA) By And Between DA-`RFU-VI And The Municipality Of Tigbauan For Project Banana (CARDABA) Production And Processing”*;

WHEREAS, the Department of Agriculture aims to strengthen the Agriculture and Fisheries Sector through Farm modernization, greater participation among the local government units, farmers, non-government organizations and people empowerment;

WHEREAS, the Municipal Government of Tigbauan is a partner of the Department of Agriculture in the implementation and dissemination of its programs and projects through the High Value Crops Development Program;

WHEREAS, the project implementation shall be through the efficient use of resources both DA and concerned LGU to boost production and development program of the beneficiaries;

WHEREAS, for and in consideration of the above premises, the parties hereby agree to undertake the project under the following terms and conditions:

I. Duties and Responsibilities of the Contracting Parties:

A. The **Department of Agriculture (DA) shall:**

1. Coordinate with the LGU's/NGO's/Coop/Assn. for the implementation of the project;
2. Allocate the total amount of One Hundred Forty One Thousand Pesos (Php141,000.00) for the Project "*Banana (Cardaba) Production and Processing*";
3. Procure the needed interventions as per approved project proposal in accordance with R.A. 9184;
4. Release the needed project interventions to the proponent/recipients upon presentation of a duly notarized Memorandum of Agreement and issuance of an Invoice Receipt or any requirement needed by DA;
5. Extend technical services specifically in the implementation, i.e. identification and validation of areas for the project;
6. Transfer the ownership and accountabilities to the recipients;
7. Conduct regular monitoring and evaluation to ascertain the progress accomplishments of the project.

B. The **Municipal Government of Tigbauan, Iloilo shall:**

1. Submit an evaluated project proposal for approval by the Regional Executive Director describing the program objectives, interventions/project components and amount requested;
2. Coordinate and assist in the identification of the recipients and validation of sites in case of infrastructures and provide necessary technical assistance;
3. Designate an Accountable Officer - who shall receive the goods/planting materials equipment/implements, who shall assume accountabilities and responsible in the distributions to the recipients and submit liquidation reports/masterlist/issue slips and other documents needed by the DA;
4. Implement the project in accordance with the objectives and specifications as provided in the approved project proposal;
5. Provide the necessary amount needed in case the project is cost-sharing;
6. Make available project records and related documents to DA-RFU VI for inspection and monitoring;
7. Monitor and submit status reports to DA-RFU VI through the Regional HVCDP Coordinator;
8. Provide necessary information and other reports as required by DA.

NOW, THEREFORE, on motion of Hon. Alfonso C. Babiera, Chairman, Committee on Agriculture, Fisheries and Cooperatives and duly seconded by Hon. Dennis Valencia, Hon. Elmer Torrato, Hon. Loreta Lungay-Arias, Hon. Marlon Teruñez, Hon. Ricky Nulada and Hon. Nyssa Nichola Callosa,

RESOLVED, to authorize Hon. James Excelsior M. Torres, Municipal Mayor, To Represent The Municipality Of Tigbauan As One Of The Signatories To The Memorandum Of

Agreement By And Between DA-RFU-VI And The Municipality Of Tigbauan For Project Banana (CARDABA) Production And Processing,
