Resolution No. 2011-091

RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HIS EXCELLENCY BENIGNO C. AQUINO III, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FOR THE IMPROVEMENT OF FARM-TO-MARKET ROAD SPECIFICALLY THE ROAD GOING TO THE MUNICIPAL SLAUGHTERHOUSE.

WHEREAS, the Municipality of Tigbauan which is composed of 52 barangays has a total population of 58,081 as of the latest census;

WHEREAS, the Local Government Unit of Tigbauan has a New Public Market and a wet market that sells meats and fishes;

WHEREAS, the slaughterhouse is the most important component of the meat section of the wet market;

WHEREAS, due to sanitary requirement, the Local Government of Tigbauan has built a slaughterhouse at Barangay 3 which is far from its former location near the public market;

WHEREAS, one of the major farm-to-market roads that needs to be improved is the road going to the municipal slaughterhouse;

WHEREAS, this farm-to-market road is very much necessary in order to transport livestock to the slaughterhouse in a more convenient and accessible way;

WHEREAS, due to budgetary constraints, the Local Government Unit lacks available funds for the improvement of such road;

WHEREAS, the realization of this farm-to-market road could be achieved through the benevolent help of His Excellency Benigno C. Aquino III;

NOW, THEREFORE, on motion of HON. ALFONSO C. BABIERA, Chairman, Committee on Agriculture, Fisheries and Cooperatives and duly seconded by Hon. Dennis Valencia, Hon. Agaton Tumabotabo, Hon. Loreta Lungay-Arias, Hon. Marlon Teruñez, and Hon. Ricky Nulada,

RESOLVED, to request Financial Assistance From His Excellency Benigno C. Aquino III, President Of The Republic Of The Philippines In The Amount Of One Million Pesos (P1,000,000.00) For The Improvement Of Farm-To-Market Road Specifically The Road Going To The Municipal Slaughterhouse,

RESOLVED FURTHER, to furnish copies of this Resolution to His Excellency Benigno C. Aquino III, President of the Republic of the Philippines, to Hon. James Excelsior M. Torres, Municipal Mayor, and to all concerned for their information and/or appropriate action.
