RESOLUTION CONFIRMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGETS OF BARANGAYS: CORDOVA SUR, 7 (POBLACION), SIPITAN AND BUGASONGAN, THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on November 18, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budgets Embodying Appropriation Ordinance of barangays:

Barangay Cordova Sur General Fund Supplemental Budget No. 2011-02 for CY 2011, involving an appropriation of P90,201.80 approved by Sangguniang Barangay on October 30, 2011 and enacted under Appropriation Ordinance No. 2011-03.

Barangay 7 (poblacion) General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P107,181.00, approved by Sangguniang Barangay on September 6, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Sipitan General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P136,341.95, approved by Sangguniang Barangay on October 15, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Bugasongan General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P142,140.85 approved by Sangguniang Barangay on October 2, 2011 and enacted under Appropriation Ordinance No. 2011-02.

WHEREAS, the Review of the foregoing Supplemental Budgets embodying Appropriation Ordinance for CY 2011 of the afore-mentioned barangays likewise show apparent

compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

Suzette Tenefrancia-Alquisada) and duly seconded by Hon. Dennis Valencia, Hon. Alfonso Babiera, Hon. Agaton Tumabotabo, Hon. Loreta Lungay-Arias, Hon. Ricky T. Nulada,

RESOLVED, to conform and approve the CY 2011 Supplemental Budgets Embodying Appropriation Ordinance Of Barangays: Cordova Sur, 7 (Poblacion), Sipitan and Bugasongan, This Municipality,
