**Resolution No. 2011- 096**

RESOLUTION AMENDING RULE VII, SECTION 1 OF RESOLUTION NO. 2010-038 (AS AMENDED BY RESOLUTION NO. 2011-049) OTHERWISE KNOWN AS THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO

WHEREAS, Rule VII, Section 1 of Resolution No. 2010-038 (as amended by Resolution No. 2011-049) provides”

**“RULE VII – REGULAR AND SPECIAL SESSIONS”**

Section 1. REGULAR SESSION

- (a) The minimum number of regular sessions of this Sanggunian shall be “once a wekk”. (Section 52 (a), R.A. 7160)
- (b) The regular session shall be held every Friday and shall start promptly at 2:00 o’clock in the afternoon. Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause the next working day shall be the regular session day.”

WHEREAS, the members of this Honorable August Body unanimously agreed to change again the schedule of the regular session of the Sanggunian considering the new schedule of classes of the Sangguniang Kabataan Municipal Federation President, Honorable Nyssa Nichola Callosa who is currently a 2<sup>nd</sup> Year BS Biology student of West Visayas State University;

WHEREAS, it is the desire of this Sanggunian to give the youth a meaningful representation and this can be fully guaranteed if their representative to this August

Chamber will not be deprived of the chance to participate in the deliberations of the matters affecting the youth in particular and the constituency in general;
