RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-11-11-262 OF GLORIA T. LASANAS ET-AL WITH TCT NO. T-121,133, LOT NO. 976-B WITH A TOTAL AREA OF 838 SQUARE METERS MORE OR LESS, CONTAINING SEVEN (7) LOTS LOCATED AT TUPAS STREET, POBLACION, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application of GLORIA T. LASANAS, with Subdivision Approval No. SA-11-11-262 with TCT No. T-121,133, Lot No. 976-B with an area of 838 square meters containing seven (7) lots located at Tupas St., Poblacion, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer of the Sangguniang Bayan, Tigbauan, Iloilo on November 16, 2011 for authorization and approval

WHEREAS, the purpose/intent of this application is to subdivide among heirs/co-owners;

WHEREAS, the said parcel of land is identified in the residential area in the zoning classification;

- b) Comply with all the corrections as indicated on the plan;
- c) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;

- d) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e) This approval does not exempt the proponent from securing registration and license to sell from HLURB.
