RESOLUTION CONFORMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGETS OF BARANGAYS: ALUPIDIAN, BAROSONG, ISAUAN, SUPA, AND 4 (POBLACION), BAGUINGIN, ISIAN, TARO, TAN PAEL GUISIAN AND SERMON, THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on December 2, 2011 and December 8, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budgets Embodying Appropriation Ordinance of barangays:

***Barangay Isian General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P 94,570.00, approved by Sangguniang Barangay on November 27, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

***Barangay Tarol General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P187,777.45, approved by Sangguniang Barangay on October 9, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

***Barangay Tan Pael General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P105,841.80, approved by Sangguniang Barangay on November 5, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

***Barangay Guisian General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P41,966.80, approved by Sangguniang Barangay on November 5, 2011 and enacted under Appropriation Ordinance No. 2011-02.***

***Barangay Sermonl General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P94,037.15, approved by Sangguniang Barangay on November 28, 2011 and enacted under Appropriation Ordinance No. 2011-02***
