RESOLUTION CONFORMING AND APPROVING THE CY 2011 SUPPLEMENTAL BUDGETS OF BARANGAYS: NAPNAPAN SUR, SAN RAFAEL, 5 (POBLACION) AND NAMOCON, THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on December 15, 2011 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budgets Embodying Appropriation Ordinance of barangays:

Barangay Napnapan Sur General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P149,500.00, approved by Sangguniang Barangay on December 3, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay San Rafael General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P119,584.65, approved by Sangguniang Barangay on November 6, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay 5 (Poblacion) General Fund Supplemental Budget No. 2011-01 for CY 2011, involving an appropriation of P97,595.66, approved by Sangguniang Barangay on October 30, 2011 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Namoccon General Fund Supplemental Budget No. 2011-02 for CY 2011, involving an appropriation of P55,000.00, approved by Sangguniang Barangay on November 21, 2011 and enacted under Appropriation Ordinance No. 2011-04.

WHEREAS, the Review of the foregoing Supplemental Budgets embodying Appropriation Ordinance for CY 2011 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Suzette Tenefrancia-Alquisada, Chairperson, Committee on Appropriation, Budget, Finance, and Legal Matters and duly seconded by Hon. Agaton Tumabotabo, Hon. Elmer Torrato, Hon. Loreta Lungay-Arias, and Hon. Ricky Nulada,

RESOLVED, to conform and approve the CY 2011 Supplemental Budgets Embodying Appropriation Ordinance Of Barangays: Napnapan Sur, San Rafael, 5 (Poblacion) and Namocon, This Municipality,
