**A RESOLUTION NAMING THE TIGBAUAN NATIONAL HIGH SCHOOL – BAGACAY EXTENSION TO BAGACAY NATIONAL HIGH SCHOOL**

WHEREAS, through the initiative of the Local Government Unit of Tigbauan for almost three (3) years now, Tigbauan National High School – Bagacay Extension has been operating as annex of Tigbauan National High School offering secondary curricula from first year to fourth year;

WHEREAS, it has been admitting enrollees for all year levels since 2008 and this keeps on expanding from year to year of operation;

WHEREAS, per evaluation, TNHS-Bagacay Extension is qualified to become an independent educational institution;

WHEREAS, a law had been passed entitled “An Act Separating The Tigbauan National High School – Bagacay Extension In Barangay Bagacay, Municipality of Tigbauan, Province of Iloilo, From The Tigbauan National High School, Converting It Into An Independent National High School to Be Known As Bagacay National High School And Appropriating Funds Therefor;”

WHEREAS, once it operates as an independent national high school, it shall be entitled to Personnel Services, MOOE or Capital Outlay as being availed by similar national high school in the country;

WHEREAS, premised considered, TNHS-Bagacay Extension is hereby renamed as Bagacay National High School;
