RESOLUTION CONFORMING AND APPROVING THE CY 2012 ANNUAL BUDGETS AND 20% DEVELOPMENT PLANS OF BARANGAYS LINOBAYAN, ATABAYAN AND BAGUINGIN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on January 12, 2012, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2012 Barangay Annual Budgets and 20% Barangay Development Plans of the following barangays:

Brgy. Linobayan CY 2012 General Annual Budget Involving An Appropriation Of P725,514.00 and 20% Development Fund in the amount of P143,822.80
Approved By Sangguniang Barangay on November 5, 2011 and December 3, 2011, respectively and Enacted Under Appropriation Ordinance No. 2012-01;

Brgy. Atabayan CY 2012 General Annual Budget Involving An Appropriation Of P1,435,465.00 and 20% Development Fund in the amount of P280,693.00
Approved By Sangguniang Barangay on November 19, 2011 And Enacted Under Appropriation Ordinance No. 2012-01;

Brgy. Baguingin CY 2012 General Annual Budget Involving An Appropriation Of P1,635,444.00 and 20% Development Fund in the amount of P320,888.80
Approved By Sangguniang Barangay on January 5, 2012 and January 6, 2012, respectively and Enacted Under Appropriation Ordinance No. 2011-01;

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budgets and 20% Development Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Appropriation Ordinance embodying the Annual Budgets and 20% Development Plans for CY 2012 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Annual Budgets and 20% Development Funds of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets and 20% Development Funds shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Suzette Tenefrancia-Alquisada, Chairperson, Committee on Appropriation, Budget, Finance, and Legal Matters and duly seconded by Hon. Dennis Valencia, Hon. Elmer Torrado, Hon. Marlon Teruñez, Hon. Ricky Nulada and Hon. Nyssa Nichola Callosa,

RESOLVED, to conform and approve the CY 2012 Annual Budgets and 20% Development Plans Of Barangays Linobayan, Atabayan and Baguingin, this Municipality,
