**Resolution No. 2012-010**

**RESOLUTION DECLARING AS LEGAL AND VALID BARANGAY ORDINANCE NOS. 2011-003 AND 2011-04 OF BARANGAY NO. 6 POBLACION, TIGBAUAN, ILOILO.**

*WHEREAS, the above mentioned Barangay Ordinances were referred to this Committee for review and after careful study, Ordinance 2011-003 and 2011-04 were found to be **LEGAL** and **VALID** considering that both are reiteration and adaptation of the salient provisions applicable to the barangay as contained in Republic Act 9003, otherwise known as "**AN ACT PROVIDING FOR AN ECOLOGICAL SOLID WASTE MANAGEMENT PROGRAM, CREATING THE NECESSARY INSTITUTIONAL MECHANISMS AND INCENTIVES, DECLARING CERTAIN ACTS PROHIBITED AND PROVIDING PENALTIES, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES**" and Republic Act 9485, otherwise known as, "**AN ACT TO IMPROVE EFFICIENCY IN THE DELIVERY OF GOVERNMENT SERVICE TO THE PUBLIC BY REDUCING BUREAUCRATIC RED TAPE, PREVENTING GRAFT AND CORRUPTION, AND PROVIDING PENALTIES THEREFOR**";*

*WHEREAS, it is also consistent with the provisions of RA 7160 or the Local Government Code of 1991, to wit:*

*"SEC. 391 Powers, Duties, and Functions. - (a) The sangguniang barangay, as the legislative body of the barangay, shall:*

*(1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinance and to promote the general welfare of the inhabitants therein;*

(14) Prescribe fines in amounts not exceeding One thousand pesos (P1,000.00) for violation of barangay ordinances;

WHEREAS, moreover, Barangay Ordinance 2011-003 - "An Ordinance Regulating The Disposal Of Solid Waste Management And Other Waste Matters" promotes the enjoyment of a balanced ecology by the people while Barangay Ordinance 2011-004 - "An Ordinance Implementing The Citizen's Charter Of Barangay 6 Poblacion, Tigbauan, Iloilo And Providing Penalties For Violation Thereof" is consistent with the time-honored principle that a public office is a public trust and all government officials are at all times accountable to the people,

NOW, THEREFORE, on motion of Hon. Jose Donel T. Trasporto, Chairman, Committee on Rules, Ordinances and Resolutions and duly seconded by Hon. Agaton Tumabotabo, Hon. Loreta Lungay-Arias and Hon. Ricky Nulada,

RESOLVED, to declare as Legal and Valid Barangay Ordinance Nos. 2011-003 and 2011-004 Of Barangay No. 6 Poblacion, Tigbauan, Iloilo,

RESOLVED FURTHER, to furnish copies of this Resolution to Mayor James Excelsior M. Torres, to Brgy. 6 Poblacion, this municipality and to all concerned for their information.
