**RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-01-12-267 OF GUILLERMO A. DE LA CRUZ ET-AL WITH TCT NO. T-192,475, LOT NO. 1-E WITH AN AREA OF 1,220 SQUARE METERS MORE OR LESS, CONTAINING THREE (3) LOTS LOCATED AT BARANGAY TAN PAEL, TIGBAUAN, ILOILO.**

WHEREAS, the Subdivision Application of Guillermo A. Dela Cruz with Subdivision Approval No. SA-01-12-267 with TCT No. T-192,475, Lot No. 1-E with an area of 2,792 square meters containing three (3) lots located at Brgy. Tan Pael, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on February 24, 2012 for authorization and approval;

- This approval does not exempt the proponent from pertinent requirements of other government agencies;
