RESOLUTION AUTHORIZING AND DESIGNATING HON. JAMES EXCELSIOR M. TORRES, MUNICIPAL MAYOR AND MRS. MA. TERESA C. TAGUMPAY, OIC, OFFICE OF THE MUNICIPAL TREASURER TO OPEN A SPECIAL ACCOUNT WITH THE LAND BANK OF THE PHILIPPINES, ILOILO CITY BRANCH FOR THE PERFORMANCE CHALLENGE FUND AND TO ACT AS SIGNATORIES THEREIN REPRESENTING THE MUNICIPALITY OF TIGBAUAN.

WHEREAS, the Municipality of Tigbauan is one of the recipients of the Performance Challenge Fund being one of the awardees of the Seal of Good Housekeeping;

WHEREAS, this Sanggunian passed Resolution No. 2012-021, "*Resolution Authorizing Honorable James Excelsior M. Torres, Municipal Mayor, to enter into A Memorandum of Agreement (MOA) with the Department of Interior and Local Government for the Implementation of the Project under the Performance Challenge Fund*";

WHEREAS, this Sanggunian with the conformity of the Department Heads and the representatives of the Office of the Municipal Mayor have identified as priority project, the development, protection and rehabilitation of coastal and riverbank areas as contained in the 2012 Annual Investment Plan of the Municipality consistent also with the Millennium Development Goals particularly goal number 7: Ensure Environmental Sustainability;

WHEREAS, in order to avail of the said Performance Challenge Fund, the municipality should open a special trust fund for the purpose of implementing the coastal and riverbank development and rehabilitation project;

Tagumpay, OIC, Office of the Municipal Treasurer to Open a Special Amount with the Land Bank of the Philippines, Iloilo City, Branch, for the Performance Challenge Fund and to Act as Signatories Therein Representing the Municipality of Tigbauan,
