Resolution No. 2012-032

RESOLUTION REQUESTING THE COMMISSION ON AUDIT (COA) TO MONITOR THE RELEASE AND UTILIZATION OF PUBLIC FUNDS IN CONNECTION WITH THE CONSTRUCTION OF PHASE 3 OF THE MUNICIPAL PUBLIC MARKET IN THE MUNICIPALITY OF TIGBAUAN AND TO ACCORDINGLY ISSUE THE CORRESPONDING FINDINGS AND RECOMMENDATIONS RELATIVE THERETO.

WHEREAS, it has been observed that several infrastructure projects of this Municipality were not fully completed and operational at the end of the supposed date of completion allegedly due to insufficiency of funds caused by increases in the prices of the construction materials;

WHEREAS, there is an on-going implementation of the construction of the Phase 3 of the Municipal Public Market and the local sanggunian ardently desire that the same will be fully implemented as planned and that no delay or irregularities will occur in the course of its implementation;

WHEREAS, consistent with the time-honored principles of transparency, accountability and good governance, this August Body aims to secure that projects particularly infrastructure and those directly affecting the general welfare of the people are lawfully implemented for the same involve the use of public funds which must be utilized consistent with existing laws, rules and regulations;

WHEREAS, in aid of coming up with possible legislative measures to safeguard the utilization of public funds at the local level and to secure the sound and regular implementation of projects, plans, and activities within the framework of the Annual Investment Plan and Development Plan of the Municipality, this Sanggunian aims to fully understand and assess the actual scenario based on findings and recommendations of competent authorities;

WHEREAS, the Commission on Audit (COA) through its duly designated Auditor/s in this Municipality is believed to be the competent authority which can issue

reliable findings and recommendations as to the propriety of releases and utilization of public funds disbursed for the implementation of projects;

WHEREAS, these findings and recommendations may be used by this legislative body for the formulation of policies and other appropriate measures to ensure the sound implementation of projects, plans and activities particularly the current undertakings of this municipality;

NOW THEREFORE, on motion of HON. DENNIS T. VALENCIA, Chairman, Committee on Market & Slaughterhouse and Infrastructure & General Services and duly seconded by Hon. Jose Donel T. Transporte, Hon. Ricky T. Nulada and Hon. Nyssa Nichola T. Callosa,

RESOLVED, to Request The Commission On Audit (COA) To Monitor The Release And Utilization Of Public Funds In Connection With The Construction Of Phase 3 Of The Municipal Public Market In The Municipality Of Tigbauan And To Accordingly Issue The Corresponding Findings And Recommendations Relative Thereto,
