RESOLUTION CONFORMING AND APPROVING THE CY 2012 ANNUAL BUDGETS AND DEVELOPMENT PLANS OF BARANGAYS BANTUD, BAROSONG AND BUGASONGAN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on *April 11, 2012*, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2012 Barangay Annual Budgets, Annual Investment Plans and 20% Development Plans of the following barangays:

Barangay Bantud CY 2012 General Annual Budget Involving An Appropriation Of P725,273.00 and 20% Development Fund in the amount of P143,959.00
Approved by Sangguniang Barangay on January 17, 2012 and January 7, 2012 respectively, and Enacted Under Appropriation Ordinance No. 2012-01;

Barangay Barosong CY 2012 General Annual Budget Involving An Appropriation Of P990,739.00 and 20% Development Fund in the amount of P143,959.00
Approved by Sangguniang Barangay on Jan. 1, 2012 and Dec. 4, 2012 respectively, and Enacted Under Appropriation Ordinance No. 2012-01;

Barangay Bugasongan CY 2012 General Annual Budget Involving An Appropriation Of P668,254.00 and 20% Development Fund in the amount of P131,150.80
Approved by Sangguniang Barangay on Feb. 5, 2012 and Jan. 1, 2012 respectively, and Enacted Under Appropriation Ordinance No. 2012-01;

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budgets, Annual Investment Plans and 20% Development Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Appropriation Ordinance embodying the Annual Budgets, Annual Investment Plans and 20% Development Plans for CY 2012 of the afore-mentioned barangays likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and

Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Annual Budgets, Annual Investment Plans and 20% Development Funds of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets, Annual Investment Plans and 20% Development Funds shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. SUZETTE TENEFRANCIA-ALQUISADA, *Chairperson, Committee on Appropriation, Budget, Finance, and Legal Matters* and duly seconded by Hon. Agaton O. Tumabotabo, Hon. Elmer T. Torrato, Hon. Loreta Lungay- Arias, and Hon. Nyssa Nichola Callosa,

RESOLVED, to conform and approve the CY 2012 Annual Budget, Annual Investment Plan and 20% Development Plan Of Barangays Bantud, Barosong and Bugasongan, this Municipality,

RESOLVED FURTHER, to furnish copies of this Resolution to the following: Hon. Mayor James Excelsior M.
