RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY, PRESIDENT BENIGNO SIMEON C. AQUINO OF THE REPUBLIC OF THE PHILIPPINES TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY MILLION PESOS (Php 30,000,000.00) FOR THE OPENING, REHABILITATION AND DEVELOPMENT OF VARIOUS FARM TO MARKET ROADS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, PHILIPPINES.

WHEREAS, the Municipality of Tigbauan is a second class municipality located in the First Congressional District, southernmost part of the Province of Iloilo with a population of 63,986 more or less based on the unofficial 2011 Population Consolidation Report by the Provincial Population Office;

WHEREAS, Tigbauan is composed of 52 Barangays and with a total land area of 8,889 hectares, 93.78% of which is devoted to agriculture and allied activities which serve as one of the main sources of livelihood of the population;

WHEREAS, the opening, rehabilitation and development of farm to market roads will ensure a convenient, fast and safe transport of farm products to the trade and economic center of the town thereby increasing the chances for economic growth and sustainable development;

WHEREAS, based on the certification issued by the Municipal Planning and Development Office (MPDO) of the Municipality as per Inventory of Road by System Classification, the existing and proposed farm to market roads classified as follows:

7. Buyu-an-Supa Road	2.67

WHEREAS, the Local Government Unit of Tigbauan cannot solely undertake the improvement of the above-mentioned roads considering the very limited sources of the Municipality but at the same the officials cannot afford to undermine the necessity of the immediate maintenance, repair and development of the said farm to market roads, thus, this request for financial assistance from the National Government is a must;

WHEREAS, the people of Tigbauan and its officials and employees are one with the vision of the current administration to lead the Filipinos into the road towards a corruption-free, honest, transparent and dedicated governance characterized by tangible and responsive programs for progress and development that is felt up to the grassroots of society;

Aquino Of The Republic Of The Philippines To Extend Financial Assistance In The Amount Of Thirty Million Pesos (Php 30,000,000.00) For The Opening, Rehabilitation And Development Of Various Farm To Market Roads In The Municipality Of Tigbauan, Province Of Iloilo, Philippines,
