RESOLUTION ENDORSING THE QUARRY PERMIT TO THE OFFICE OF THE PROVINCIAL GOVERNOR, PENRO, DENR, REGION VI AND THE BUREAU OF MINES AND GEOSCIENCES, FOR ORDINARY EARTH QUARRY APPLICATION AND FOR THE ENVIRONMENTAL COMPLIANCE CERTIFICATE FOR SERAFIN TABARES OF BARANGAY SIPITAN, TIGBAUAN, ILOILO

WHEREAS, the Municipality of Tigbauan, Iloilo has been a good source for sand and gravel as well as ordinary earth materials, supplying both commercial and non commercial infrastructure development in the municipality, city and Province of Iloilo;
