**Resolution No. 2012-047**

**RESOLUTION RESPECTFULLY REQUESTING THE SANGGUNIANG PANLUNGSOD OF ILOILO FOR RECONSIDERATION TO ALLOW THE TIGBAUAN PUJs TO CATER THE TRANS-LOADING OF PASSENGERS FROM MOHON TERMINAL GOING TO TERMINAL MARKET VIA INFANTE ROAD, ILOILO CITY AND VICE VERSA.**

WHEREAS, Section 16 of the Perimeter Boundary Ordinance of Iloilo City provides that Provincial PUJs coming from their municipalities of origin, who are non-holders of PUJ Passes are prohibited to “trans-load” (*by transferring or passing over passengers to another Provincial PUJ who are holders of PUJ passes*) unless the representatives of Provincial Public Utility Jeepneys, City Loop Jeepneys, Terminal Operators and the Transportation Management & Traffic Regulation Office have agreed in writing for other arrangements, the terms of which shall be approved by the sanggunian;

WHEREAS, the above-quoted Section shall give provincial PUJs the authority to transport passengers from Mohon Terminal going to Iloilo Terminal Market via Infante road as an exception to the general rule established by RO No. 2012-194 providing for twenty (20) Villa Mohon Iloilo City Proper passenger jeepneys to cater passengers from Southern Iloilo going to the City Proper;

WHEREAS, meetings were previously called by the City Council and the Transportation Management and Traffic Regulation Office (TMTRO) in order to settle issues and concerns surrounding the implementation of RO No. 2008-32 as amended by RO No. 2012-197 on trans-loading of passengers;

WHEREAS, the Tigbauan Jeepney Operators and Drivers Association (TJODA), failed to signify their intention to make the corresponding arrangement with the City Government as regards trans-loading of passengers as provided for in the City Ordinance;

WHEREAS, this failure to make the necessary arrangement and agreement with the City Government forfeited their chance to trans-load passengers lawfully to the prejudice of the riding public especially during rush hours, which causes so much inconvenience to the passengers;

WHEREAS, TJODA appealed to this Sanggunian to mediate and seek the needed consideration from the Iloilo City Government through the City Council and the TMTRO so that they may enter into an agreement allowing TJODA to trans-load passengers on terms and conditions as may be agreed upon by the parties;

WHEREAS, this Sanggunian recognizes and give full respect to the rules and regulations imposed by the City of Iloilo on matters affecting their jurisdiction but this August Body cannot simply turn its back from the needs of its constituency, thus this appeal to the City Council and TMTRO to reconsider the request of the TJODA to make the necessary arrangement in order to lawfully trans-load passengers from Mohon Terminal going to Iloilo Terminal Market via Infante Road;

WHEREAS, the said arrangement will benefit the people of Tigbauan especially the riding public who wish to visit the City of Iloilo in a safer and more convenient way;

NOW, THEREFORE, on motion of HON. MARLON R. TERUÑEZ, Chairman, Committee on Transportation, Communication and Energy and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, and Hon. Jose Donel Trasporto,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to respectfully request the Sangguniang Panlungsod of Iloilo for Reconsideration to Allow Tigbauan PUJs to cater the Trans-loading of Passengers from Mohon Terminal Going to Iloilo Terminal Market Via Infante Road, Iloilo City and Vice Versa,

RESOLVED FURTHER, to furnish copies of this resolution to the Sangguniang Panlungsod of Iloilo and to Hon. Mayor James Excelsior M. Torres for their information, guidance and/or appropriate action.
