RESOLUTION IDENTIFYING THE ROAD FROM JUNCTION TUPAN STREET TIGBAUAN, ILOILO GOING TO THE MUNICIPAL SLAUGHTER HOUSE AS THE STO. NIÑO ROAD REFERRED TO IN THE DPWH PROPOSED MUNICIPAL ROAD PROJECT.

WHEREAS, the Department of Public Works and Highways (DPWH) will be constructing a municipal road worth 1.5 million pesos for the Municipality of Tigbauan, Iloilo as one of its target projects for the First Congressional District of Iloilo;

WHEREAS, in its proposal, DPWH mentioned a certain Sto. Niño Road as the target area which, after consultation with the proponents and the persons involved for its planning and implementation, was found out to refer to the road from the junction of Tupan Street going to the current Municipal Slaughter House at Barangay 3 Poblacion, Tigbauan, Iloilo;

WHEREAS, the identification of the road from the junction of Tupan Street going to the current Municipal Slaughter House as the Sto. Niño Road referred to in the DPWH project proposal will avoid confusion and will facilitate the immediate and effective realization of the said project;

WHEREAS, the said infrastructure development will serve as a convenient gateway to one of the most important economic and trade centers of the Local Government Unit, the municipal slaughter house, which is a potent source of local income for Tigbauan;

NOW THEREFORE, on motion of JOSE DONEL T. TRAPORTO, Chairman Committee on Rules, Ordinances and Resolutions and duly seconded by Hon. Suzette Tenefrancia-Alquisada and Hon. Marlon Teruñez,

RESOLVED, to identify the Road From Junction Tupan Street Tigbauan, Iloilo Going To The Municipal Slaughter House As The Sto. Niño Road Referred To In The DPWH Proposed Municipal Road Project,
